GUEST SPEAKERS

CITY OF PHOENIX MAYOR



Phoenix Mayor Greg Stanton was raised in West Phoenix, by a family committed to giving back to their community. His dad, Fred, rode the city bus to his job as a shoe salesman and his mom, Mary Ann, was a devoted educator. The Stantons instilled in their children the importance of giving to others, and in that spirit they founded the Christian Needs Network, a group of multi-

faith volunteers who collected clothes, food and diapers for members of their community in need.

Following high school, Greg attended Marquette University and earned the Harry S. Truman Scholarship, a national award for students committed to pursuing careers in public service. While at Marquette, he and a classmate founded an after-school program at the Downtown Milwaukee YMCA helping fourth and fifth grade students with homework and basketball. He also was awarded a grant from the Milwaukee Foundation to study inner-city hidden unemployment.

After earning his law degree from the University of Michigan, Greg returned to Phoenix where he practiced education law at Jennings Strouss & Salmon and later practiced law at Quarles & Brady LLP. In 2001, he left private law practice to serve on the Phoenix City Council, where he represented the sixth district for nine years. This district includes the Biltmore, Ahwatukee Foothills, Arcadia and North Central neighborhoods. With a staunch commitment to creating high-wage jobs in Phoenix, Councilman Stanton was the lead councilman bringing the Translational Genomics Research Institute (TGen), the ASU downtown campus and the U of A medical school to the city.

In 2009, Greg joined the state Attorney General's office as Deputy Attorney General, where he helped lead the effort to stop the funding of cartels who traffic people and drugs across our southern border. He worked to protect consumers and homeowners by fighting the predatory payday lending industry and focused on eliminating mortgage fraud. He also negotiated the settlement between the State of Arizona and Maricopa County to protect the future vitality of Luke Air Force Base, a \$2 billion-a-year economic asset.

Greg and his wife Nicole have two young children, Trevor and Violet. Nicole is a prominent local attorney who recently received the YWCA business leadership award. Both Greg and Nicole support a city with strong schools, safe parks and neighborhoods, a vibrant arts community, and an environment that supports locally owned businesses, diverse industries and high-wage jobs. As mayor, Greg is working to make that a reality.

During his first full year in 2012, Mayor Stanton continued his commitment to building a stronger city based on sustainability, a vibrant local economy and a quality education system.

KEYNOTE SPEAKER



Betsey Martens is the Executive Director of Boulder Housing Partners (the public agency serving Boulder, Colorado) and was elected President of the National Association of Housing and Redevelopment Officials, the United States' largest affordable housing professional association.

During her 15 year tenure with Boulder Housing Partners, Betsey has used innovative funding mechanisms and a strategic approach to develop or acquire 14 new properties and 445 affordable homes serving the diversity of housing needs in Boulder. Under her leadership, BHP garnered numerous awards and recognition, and was selected by HUD as a demonstration site with broad discretion to redesign its programs (Moving to Work). As a national leader, Betsey has testified before two Congressional Committees and helped develop consensus among national housing advocacy organizations to produce a milestone joint statement of affordable housing policies and funding priorities.

Betsey has worked in the affordable housing and community development field for 30 years, having been a Community Action Director, a housing authority Commissioner, a CD program director and a NAHRO regional staff officer. She has published articles on timely housing issues and also taught an under-graduate class in Housing Policy at the University of Colorado.

2012/2013 YEAR IN REVIEW

All of our member Agencies have been subject to severe budget cuts from the Federal Budget Sequester. Tighter budgets mean more work for existing staff, and less time for working towards industry wide goals with groups like NAHRO. Even worse, tight budgets mean fewer families served, longer waits for housing assistance and a reduced ability to maintain our housing stock. Now more than ever, we need to work together to advocate for our industry and the families we help. Now more than ever we need to make sure that we maintain high levels of professionalism by providing the training, information and tools needed to do our jobs well. There is power in numbers – now more than ever AZNAHRO needs your support and participation.

The irony of our budget woes is that to protect our mission as affordable housing agencies, we need to speak together clearly, and we need the affordable professional training sessions that AZNAHRO can bring. But our time and dollars are squeezed tighter and tighter and we feel less able to volunteer, less able to afford needed training. There is power in numbers, and working together we can continue to provide these services. To achieve this, AZNAHRO needs more member participation. Take a look at our board roster and you will see that we have had several very important board vacancies. We have struggled this year not only because everyone's load at work is heavier than ever, but also because several board officers resigned – because of work changes, retirement and health issues. Luckily, we have put together a fabulous slate of officers and feel very positive about the 2013 -2014 board, but our committees are in need of more members.

ADVOCACY

AZNAHRO and AHADA worked together to write the 2013 Arizona Legislative Priorities Paper. Deborah Beals, AZNAHRO President, was primarily responsible for writing the document. Ms. Beals attended the NAHRO Legislative Conference held in March, 2013 in Washington DC. Ms. Beals and Chapter member Dan Trozzi met with a number of Congressional representatives to present the paper. Additionally, President Beals kept the advocacy going here in Arizona by meeting with Representative Kyrsten Sinema in April, 2013. In May, AHADA members Elaine Adamczyk, Karl Matzinger, and Gloria Munoz met with Congressman Pastor. They discussed the effects of sequestration on our rental assistance programs. We will continue to advocate for full funding and reasonable regulations on our programs in the coming year. Your membership and participation with AZNAHRO helps us to present a cohesive and clear message to our elected representatives. Our website contains a link you can use to contact your Representatives; please take the time to speak up for the families we represent.

As a member-driven organization, we respond to our local needs by bringing needed training sessions to Arizona at a reduced price for our members. This year, we sponsored:

HOW CAN YOU PARTICIPATE?

Volunteering for AZNAHRO is not a huge time commitment, and with strong member participation, we are a strong organization. Participation on a committee takes an average of one hour a month, but the work flow varies depending on the time of year and committee activities. Participation at committee meetings can be either in person or over the phone. We have a phone conferencing system that works great for long-distance meetings – a great way to save on driving time. The basic responsibility of committee members is to identify member needs and bring relevant training and meetings to our members to meet those needs.

I'd like to describe a year on the Finance Committee to demonstrate what the work flow looks like. In 2011, the Finance Committee saw a lot of new accounting and finance people coming into the profession. It responded by setting up two professional seminars by national trainers right here in Phoenix. One committee member handled coordinating with the trainer, another found a free location, another figured out how to feed folks and they held a great training at a low cost. The seminars were well attended and were a lot cheaper than attending one of the “regular” sessions by the same trainer. Why? Because AZNAHRO did not need to make a profit on setting the sessions up, put leg work into finding a free site and advertised only to our members. Another big role for committee members is helping to set up sessions for the Annual Conference. The 2011 Finance Committee; the committee had five members, and needed to identify five sessions for the 2011 conference. The committee met to brainstorm ideas, and each member took responsibility for setting up one session. The work was divided up and no one person had to “do it all”.

Please show your commitment by joining one of our committees. Look around at the people attending the Conference. Board Members and Committee Members have ribbons to identify them. Stop one of us to chat about what it is like to volunteer for AZNAHRO. Or fill out one of the committee interest forms available in each session. We need you now more than ever.

GROWN-UP GRILLED CHEESE SANDWICHES

A new take on a familiar favorite pairs grilled cheese with a BLT for a luscious veggie-packed sandwich that feels like an indulgence.

Ingredients

- Cooking spray
- 1 cup vertically sliced red onion
- 1 large garlic clove, minced
- 1 cup (4 ounces) shredded reduced-fat sharp white cheddar cheese (such as Cracker Barrel)
- 8 (1 1/2-ounce) slices hearty white bread (such as Pepperidge Farm)
- 2 cups fresh spinach leaves
- 8 (1/4-inch-thick) slices tomato
- 6 slices center-cut bacon, cooked

Preparation

1. Heat a large nonstick skillet over medium-low heat. Coat pan with cooking spray. Add 1 cup onion and garlic; cook for 10 minutes or until tender and golden brown, stirring occasionally.

2. Sprinkle 2 tablespoons cheese over each of 4 bread slices. Top each slice with 1/2 cup spinach, 2 tomato slices, 2 tablespoons onion mixture, and 1 1/2 bacon slices. Sprinkle each with 2 tablespoons cheese; top with the remaining 4 bread slices.

3. Heat skillet over medium heat. Coat pan with cooking spray. Place sandwiches in pan, and cook for 3 minutes on each side or until golden brown and cheese melts.

Employee of the Year: Community Development

Glenn Fournie

Project Coordinator, City of Tucson Housing and Community Development

Chances are, if you have attended a Tucson Homeless Connect event, witnessed the life-changing influence of the 51 Homes project, volunteered to help build homes for Habitat for Humanity, or been to a fundraiser for Southern Arizona AIDS Foundation, you have met Glenn Fournie. Glenn has been a strong advocate for the most vulnerable members of the Tucson community, and for this reason, we proudly award him Employee of the Year: Community Development.

Glenn began assisting with the 51 Homes Campaign in 2010. In April 2011 he canvassed the streets and washes of Tucson as part of a team working to locate and prioritize the most medically vulnerable homeless persons to assist them in moving off the streets. Since working with this program Glenn has effectively recruited volunteers for a variety of needs such as moving furniture, sorting donations, or decorating an apartment for a homeless veteran.

Glenn's major role has been securing donations - such as surplus beds, bed frames and bedroom furniture from Davis Monthan Air Force Base - and purchasing everyday necessities to outfit each home. He coordinates each new move-in, personalizing each apartment for its tenant with furnishings, decorations and a kitchen with a fully stocked pantry. Again, by way of donation, Glenn has been able to use a warehouse to store the donated furniture and household items until they are needed for an apartment.

The time Glenn spends physically and mentally to help this program is admirable. In fact, Glenn's selfless labor has helped to obtain donations and funding to furnish 39 apartments for 51 Homes and 61 apartments for Veterans housed by the VA and City of Tucson through VASH vouchers and the 100 Days Veterans Initiative.

Further demonstrating his commitment to these programs, Glenn enjoys asking guests at a party or holiday gathering to make a charitable contribution to Homeless Connect or 51 Homes, rather than exchanging gifts. He also was recently designated an Honorary Squadron Commander of the 335th Contracting Squadron at Davis Monthan AFB, originating from days of moving furniture for 51 Homes and his leadership.

Glenn has played a leading role in planning and running Tucson Homeless Connect, which is a "one-stop" services biannual event, offered to Tucson area homeless individuals and families - with often over 400 people receiving services each time. Approximately 40 non-profits and government agencies attend and Glenn has participated by recruiting agencies, obtaining donations of cash and goods, gathering personal hygiene items for care kits, and coordinating food to serve at nine events.

Employee of the Year: Public Housing

Consuelo Figueroa

Senior Eligibility Worker, Yuma County Housing Development

Consuelo has been employed with the Yuma County Housing Department (YCHD) since 1987; she was hired as a clerk and promoted to Senior Eligibility Worker in February 2000. During the Yuma County Employee Recognition held in April 2013, she was recognized for her 25 years of dedicated service to Yuma County. In December 2012, she was awarded The YCHD Employee of the Quarter because of her diligent efforts, resourcefulness and contribution towards the accomplishment of YCHD's mission.

YCHD is a small housing authority with 159 public housing units (PH) and 401 Sec 8 Vouchers (HCV). As an eligibility worker (EW), Consuelo manages the caseloads of both the PH and HCV programs with two other eligibility workers. Because of the recent federal program funding cut brought about by the sequestration, YCHD had to undergo a period of reorganization and attrition. With one less EW, Consuelo has stepped up immeasurably during these critical staff shortages by filling in as the occasion demands. Her case management caseload has increased from an average of 300 to about 440 a year. The many documents called upon to originate are properly submitted and filed in a correct, concise, and timely manner. This was evidenced by the recent SEMAP score of 100% and a positive comment made by a HUD Field office staff after an on-site SEMAP review this year. Consuelo treats customers with respect and courtesy. She listens and responds to customers promptly and is capable of good, spontaneous judgment and decision making. Consuelo has taken initiative to prepare a proactive plan of action with new ideas and forms to streamline the workload that has been added to the EWs. As a valuable and indispensable team member, she has continuously demonstrated exceptional leadership and initiative that served as forerunner in the organization and led to unsurpassed excellence.

For demonstrating excellence in the performance of duties with the highest degree of integrity and professionalism, demonstrating courtesy, concern, responsiveness, and dedication in both the Public Housing and Housing Choice Voucher programs, it is with distinct pleasure that Consuelo Figueroa is awarded as Employee of the Year: Public Housing in the 2013 AZNAHRO/AHADA Excellence Awards.

Employee of the Year: Housing Maintenance

Juan Lara

Lead Housing Technician, City of Tucson Housing and Community Development

Juan Lara was the Lead Housing Technician at the Tucson House Apartments for five years and is now servicing Martin Luther King apartments and scattered sites. The Tucson House was built in 1963 and requires skilled labor to keep it running. Juan made it a priority to learn the plumbing and electrical setup of the building. His initiative and genuine concern for the residents has prompted many building improvements. Juan was involved with the cleaning of all plumbing stacks, a year-long project which helped to ensure residents had properly running drains. Juan assisted with creating a record of water valves for preventative maintenance, installed access panels in hallways to minimize disturbance to residents and provided training to help residents better understand how their plumbing works.

Juan also worked with Environmental Services to improve the trash service for residents so they would not have to throw heavy trash bags into the chute. He has also shown initiative by learning troubleshooting techniques related to the elevator operation. This has saved on evaluation times and resulted in speedier repairs.

Recently Juan was asked to handle the maintenance inventory for Tucson House and Lander Garden. This was a new venture for the technicians, but Juan took on the challenge with a positive attitude and efficient results. He maintains the swimming pool at the Tucson House, and stays current on code changes relating to the upkeep of public pools.

Juan has been a great example to his peers as a professional Housing Technician. He is regarded as the “go to” guy when technicians need help with difficult repairs. He respects the Housing Program and supports its rules by helping residents maintain compliance.

Juan also serviced the Lander Gardens site, which was in need of many repairs when first assigned to him. Juan met with the manager to arrange a plan for site improvements; the end result was a high score in the 90s on the HUD physical inspection - a score never received before at this site! Juan is the definition of an outstanding Lead Housing Technician.

Employee of the Year: Section 8

Tracey French

Housing Specialist, City of Flagstaff Housing Authority

Tracey French is a Section 8 Housing Choice Voucher Housing Specialist for the City of Flagstaff Housing Authority. Over the past year and a half, Tracey has taken on many extra duties to help agency programs run smoothly. Tracey coordinated an outreach program for briefing existing residents and landlords, including program development, mailings to residents and landlords, scheduling of sessions at different days and times to reach as many participants as possible, and developing a Powerpoint presentation. The program reached over 95% of the participants and received great reviews.

Secondly, Tracey took on the challenge of revising the City of Flagstaff briefing packet. By moving some information from the printed packet onto the website, Tracey reduced the cost per packet from twenty dollars to five dollars, resulting in a substantial savings for the program.

Thirdly, Tracey wrote Standard Operating Procedures for all phases of the Section 8 Program. Her comprehensive SOPs cover everything from application intake through lease up, annual recertifications and continuing assistance. She includes narrative descriptions of actions to be taken, screen shots and instructions for software processing, as well as checklists for various processes (i.e. move-ins, recertifications, etc.) Tracey also ensures that forms are kept up to date with all regulatory and procedural changes.

With all these responsibilities, Tracey manages to keep her caseload work current and accurate. But wait, there's more - Tracey also volunteered with VITA, a free tax preparation service provided through United Way of Northern Arizona. The service is available to those with incomes below \$49,000. In 2013, approximately 25 Voucher holders utilized the service. The program also ensures that our low-income clients receive the earned income tax credit, which ranged from \$1,000 to \$4,000. Tracey also volunteered at Project Connect, a community-wide one-day outreach effort to connect low-income families with housing and other local services.

Innovative Program of the Year: Community Development

100,000 Homes Campaign Mike Shore, HOM, Inc.

It's one of the most heartbreaking things we see on the streets—individuals and families, often with young children, lacking any place to call home. Launched in 2010, the 100,000 Homes Campaign works with communities to identify vulnerable individuals and families with children in order to move them into permanent housing that meets their service needs and keeps them together.

The 100,000 Homes Campaign is a national movement of over 212 communities working together to find permanent homes for 100,000 chronic and medically vulnerable homeless Americans by July 2014. With one year left in the Campaign, 60,398 formerly homeless Americans are now permanently housed and the Campaign is on track to meet its goal of 100,000.

Powered by Community Solutions and supported by a broad base of national and local partners, the Campaign helps communities transform their homeless services systems into solution systems capable of ending street homelessness for good. Maricopa County was one of the first communities to join the Campaign in 2010 and the local Campaign efforts, Project H3 and Project H3 Vets, have successfully housed over 368 individuals and families throughout the region to date, while also helping to cement evidence-based best practices like housing first, peer support navigation and targeting and prioritization to our homeless services systems.

Mike Shore believes in this movement so much that he stepped away from the day to day operations of running HOM, Inc. so he could devote his time to the 100,000 Homes Campaign. As Director of Operations for the Campaign, Mike works with communities across the country to embed its core tenets into the work of ending homelessness:

- Knowing everyone experiencing homelessness by name and with enough information to provide the most appropriate housing and services to end their homelessness
- Tracking monthly progress of permanent housing placements with an aim to get on track to end chronic homelessness by 2015
- Improving local systems through targeting and prioritization, implementation of housing first and increasing access to mainstream resources to end homelessness

Mike is also CEO of HOM, Inc., a leading provider of permanent supportive housing solutions for individuals and families experiencing homelessness. HOM, Inc. manages approximately 1,200 scattered sites, permanent supportive housing vouchers throughout Maricopa County in behalf of Arizona Behavioral Health Corporation. HOM, Inc. also contracts with public housing authorities like the Arizona Department of Housing, City of Phoenix Housing Department, City of Mesa Housing Department and City of Scottsdale Housing Authority to perform other services including HUD-VASH lease-up services, HQS inspections and hearing officer review services.

As a 19-year member of Arizona NAHRO, Mike works extensively with local housing authorities and has a comprehensive understanding of the Housing Choice Voucher (HCV) program. Mike is also Vice Chair of the board of directors for the Arizona Coalition to End Homelessness and serves on Phoenix Mayor Stanton's Homeless Advisory Committee.

Innovative Program of the Year: Housing

The Bridge Family Campus, Foundation for Senior Living City of Phoenix Housing Department

The Bridge Family Campus, located at 1850 W. Angela Drive, is the result of a partnership that combines the talents of two established non-profit agencies; Foundation for Senior Living (FSL) and Save the Family Foundation of Arizona. FSL has been developing affordable housing for several years, mostly to serve lower income seniors. Recently, FSL sought partnerships with other organizations wanting to create more housing for their particular clientele, but lacked the expertise to carry it out. In the case of The Bridge Family Campus, FSL had purchased land and Save the Family was approached about the project. Save the Family saw the offer as an opportunity to consolidate its traditional homeless family program. As a result, FSL was able to proceed with a 15-unit new construction project allowing Save the Family to expand their program to the presently underserved area of north Phoenix.

The Bridge project represents the best of green, energy-efficient construction. Each living envelope is secure with air infiltration limited to a few pascals. The living units have terrific sound proofing and the construction materials were chosen to stand up to the demands of many families for years to come. The construction contributes to the success of the program and in turn the families that live there by reducing cost of utilities and operation, allowing more of the precious public/private funding to be used for programming and support services.

The Bridge Family Campus consists of the construction of 15 units in two buildings and a community center building to serve the families. The two residential structures include a one-story building containing five units and a two-story building containing ten units. There are 12 two-bedroom units and 3 three-bedroom units. The project is primarily funded by the City of Phoenix with a \$1,500,000 forgivable HOME Investment Partnerships Program (HOME) loan and an \$880,000 forgivable Community Development Block Grant (CDBG) loan. Other funding for the project includes a \$240,000 Federal Home Loan Bank Affordable Housing Program (AHP) grant and FSL equity.

Save the Family will be utilizing Supportive Housing Program funds to operate the program. The Bridge Family Campus supports HUD's goals by helping to end homelessness for families, expanding the supply of this type of housing to an underserved area and significantly improving quality of life for the families through the array of services and job training opportunities provided by Save the Family.

FSS Participant of the Year

Ramona Valenzuela
FSS Participant, City of Phoenix

Ramona was a victim of domestic violence and in December 2008, her significant other attempted to kill her in front of her children. As a result, she sought safety and resided in a domestic violence shelter for four months. At that time she received housing assistance from the City of Phoenix.

At the time of her FSS intake in 2011, Ramona had just enrolled in the Pipe Fitter Apprenticeship Program and her annual income was \$8,671. She lived in a Section 8 unit with her three children ages 5, 10 and 11. Her initial TTP was \$181.00.

During Ramona's participation in the FSS program, her annual income increased to \$49,472. She plans to complete the Pipe Fitter Apprenticeship Program and her Associate in Applied Science Degree within the next three years. After that she will continue her education to obtain a Bachelor of Science Degree in Mechanical Engineering.

Ramona had no credit history when she joined the FSS program. She completed the financial education series and met with credit counselors to work on building her credit - and in time, she was approved for a home loan. On December 18, 2012, Ramona closed on her new home.

Ramona saved her tax refunds for two years and diligently made monthly deposits to her savings account; she was able to save \$20,000 that was applied to her down payment. In addition, she received \$15,000 assistance from the City of Phoenix Neighborhood Stabilization Program. Her good credit helped her to obtain a low loan interest of 3.125% and her monthly payment is \$583 (\$4 less than her contract rent).

Ramona has been an exemplary FSS participant. The requirements of FSS include maintaining employment, attending financial education classes, obtaining credit reports and demonstrating increasing self-sufficiency by managing personal financial resources. Ramona has completed all of these goals and more.

Ramona is optimistic and determined to continue moving forward even when challenges come her way. The City of Phoenix FSS team is proud of her and her accomplishments, and happy to see her presented with the 2013 AZNAHRO/AHADA FSS Participant of the Year.

Bruce Tran

Bruce enrolled in the Family Self-Sufficiency program in August of 2008. A full-time student prior to participating in the FSS program, Bruce was ready to put some of the skills he had learned into practice. He graduated from East Valley Institute's Nursing program where he completed the Licensed Practical Nurse (LPN) program. He currently is utilizing his language skills and medical background to assist Vietnamese speaking clients during their medical appointments with Pacific Interpreters during the day and Cyacom in the evening. At one time, Bruce held a total of three jobs, working diligently towards his goal of homeownership. His future goal is to continue working his two interpreting jobs and enroll in the RN program.

Bruce and his mother Kim opened an IDA account and worked closely with Newtown towards their goal of becoming homeowners. He was able to apply both his escrow and IDA funds together to purchase their new home in April of this year. With his drive and determination, Bruce will be successful in all that he strives for!

Jayne Wittman is a Public Housing Specialist for the City of Flagstaff Housing Authority. Jayne has demonstrated her commitment to service in many ways. Her professional career choices have always been service oriented. Before working with the Housing Authority, Jayne worked with the Head Start program helping families with young children gain early childhood development skills. The VITA program also ensures that low-income clients receive the earned income tax credit, which Jayne states ranged from \$1,000 to \$4,000. Jayne has volunteered to serve on the AZNAHRO membership committee, and at this year's conference she can be found helping out at the registration table. Also for the conference, she gathered a basket of Flagstaff-related goodies for the FSS silent auction - the first time FHA has contributed a basket to the auction.
